

Conditions of participation in Müpa Budapest's Colour Concerts:

- Performers must be students of the Liszt Ferenc Academy of Music. A member of the Academy's teaching staff may also participate as a piano accompanist.
- We can only accept applications submitted via a fully completed form (including all mandatory fields)
- The concert programme should be 50-60 minutes in length, without breaks. Please provide the planned programme in the most precise form possible (opus, number, movement number, etc.) Finalization of the programme - in order to ensure that the presented programme fits into the Müpa program structure – will be based on further consultation.
- The provided performers and programme information will be published in edited forms, both in Hungarian and English, on the Müpa website.
- Appearance on performance day should be in proper attire and at least one hour before the start of the performance.
- If you are advertising the concert among your friends or on social media, please be aware that the venue has a limited capacity (100-130 people in the Glass Hall). If the number of people who show up exceeds this, we will not be able to admit those who arrive in excess of the full capacity.
- We would like to inform you that the location or in some rare cases the date of Müpa Budapest's Colour Concerts may change with respect to what has been previously discussed depending on other events taking place in the building. We are trying to arrange house programs so that this occurs in the rarest of cases but – needing to take into consideration the institution's complex order of operations – we cannot rule out such changes. Our goal in these cases is to seek an acceptable solution for all.

- **Remuneration of performers:**
 - After the performers have completed their concert duties, they are entitled to remuneration in the amount of HUF 27 000 + VAT /person (in case of payment as a private person – without invoice – the amount is gross HUF 27.000 Ft / person) .
 - in case of more than 7 people - regardless of the number of people – they are entitled to remuneration in the amount of maximum HUF 189 000 + VAT.
 - Remuneration of doctoral students or professionals providing invoice per person is HUF 32 500 + VAT.
 - In addition to the name of the performer, please always indicate whether it is a doctoral student or a professional accompanist.
- In exceptional cases, Müpa may record audio and video during the performance. If a recording is made of a concert, the following rules apply:

- The Performer authorizes Müpa to record the performance in audio or audio-visual form (hereinafter referred to as: Recording) for the purpose of broadcasting or any other means of communication to the public.
- Müpa is the owner of the Recording and the sole holder of the producer rights associated with the Recording.
- Production of the Recording is Müpa's sole discretion.
- Müpa, as the sole owner of the producer rights of the Recording, is entitled to use the Recording made on the basis of the above license either in its entirety, in parts or as a cross-section in the territory of Hungary and abroad without any kind of spatial, time or method restrictions, for any purpose compatible with the event, including commercialization on a material carrier or in any other way, and is entitled to further license the above usage rights to third parties without any additional fees.
- Müpa undertakes a legal guarantee and responsibility that the Recording produced in this way does not fall into the possession of an unauthorized third party and will not be used in an unauthorized manner.
- Contributors may not make any financial claims to Müpa in connection with the recordings used.
- By applying, performers accept the above terms and conditions.
